**Ingredients:** bulking agent: cellulose; Mistletoe (*Viscum album L.*) sprigs powder; Hawthorn (*Crataegus monogyna jacq.*) flowers and leaves d.e. 0.5% vitexin; coating (glazing agents: hydroxypropyl methylcellulose, cellulose; stabilizer: glycerol; concentrates of: safflower, radish, apple, black currant, sweet potato, cherry; maltodextrin; acidifier: citric acid); Olive (*Olea Europea L.*) leaves d.e. 6% oleuropein; Garlic (*Allium sativum L.*) bulb d.e. 1% aglin; anti-caking agents: silicon dioxide, magnesium salts of fatty acids, mono and diglycerides of fatty acids; Valerian (*Valeriana officinalis L.*) root d.e. 0.8% valerinic acid.
